IHSS Budget Letter– Repeal 7% Cuts (Second update with additional organization sign-ons) March 16, 2021

RE: IHSS Budget – Permanent Restoration of the 7% Across-the-Board Hours Cut

Dear Senator Talamantes Eggman and Assembly Member Arambula:

The undersigned 56 organizations appreciate the Governor's budget proposal to extend the restoration of In-Home Supportive Services (IHSS) service hours until December 31, 2022 but believe the provision should be permanently repealed. We, therefore, respectfully request a permanent repeal of the 7% IHSS hours cut by rescinding Welfare & Institutions Code § 12301.01 through 12301.05.

The IHSS program keeps Californians with disabilities, including seniors, in their own homes and saves taxpayers hundreds of millions of dollars in doing so. If implemented, the 7% cut to IHSS hours would be devastating to IHSS consumers and providers:

 A consumer assessed as needing the average number of monthly hours would lose 8 of those hours – those service hours are needed for feeding, meal preparation, bathing,

- and other authorized tasks. A consumer who is assessed as needing the maximum number of 283 hours would lose 20 hours of help per month more than two days of personal care or domestic services. The need for personal care services is not going away but the help would.
- The 7% reduction in IHSS hours means IHSS providers working for the average IHSS consumer would lose \$119.52 of their monthly income. Decreased wages means consumers will have a more limited supply of home care workers, making it difficult for them to remain safely in their homes and possibly forcing them into institutions such as nursing homes. Many IHSS providers already live in poverty and are eligible for food stamps. Because of the loss of income, many IHSS providers may seek work elsewhere.

The Governor's proposed FY 21/22 budget provides funding to restore IHSS service hours – but only until December 31, 2022. IHSS consumers need all the hours they are allotted, and it is stress-inducing and destabilizing to have this possible cut hanging over people's heads. We respectfully request a permanent repeal of the 7% cut to IHSS.
